 - The 2023 World Service Conference directs the Board of Trustees (BoT), to form a representative ad hoc committee of no more than 12 trusted servants comprised equally of Group Service Representatives, Area Service Committee or Regional Service Committee ... ** AMENDED: See Conference Minutes ** PASSED
- ▶ Motion 87 from WSC 2023 FINAL COMBINED Minutes Tuesday, May 2, 2023 pg 5:
 - The 2023 World Service Conference directs the Board of Trustees (BOT), to form a representative ad hoc com committee of no more than 12 trusted servants comprised equally of Group Service Representatives, Area Service Committee or Regional Service Committee Officers, National Service Office Officers, and Board of Trustees members to research and interview other 12 Step Fellowships and, identify best service structure practices to fulfill Nar-Anon's Mission Statement.
 - The ad hoc committee is responsible to provide a written report quarterly of its activities and findings to the Board of Trustees. The ad hoc committee will present a verbal and written final report of recommendations at the Interim World Service Conference 2024 for discussion, review, and revision. The draft final report and recommendations document will be circulated in the Conference Agenda Report 2025 to the World Service Conference 2025. The ad hoc committee is granted permission to originate motions for inclusion in the Conference Agenda Report 2025 (CAR 2025).

The circle stands for the whole world of A.A., and the triangle stands for A.A.'s Three Legacies of Recovery, Unity, and Service.



Narcotics Anonymous (NA)

The outer circle denotes a universal and total program that has room within it for all manifestations of the recovering person. The square base of the Pyramid denotes Goodwill. The four pyramid sides that rise from the base in a three-dimensional figure represent Self, Society, Service and God. All rise to the point of Freedom.

Al-Anon

The three sides of the triangle symbolize our three Legacies: Recovery through acceptance of the Steps, Unity through acceptance of the Traditions, and Service through acceptance of the Concepts. All three sides are necessary for the triangle to remain a triangle, just as a three-legged stool needs all three legs to stand. The circle within the triangle has been described by some Al-Anon members as a circle of welcome that carries the Al-Anon message of hope to the many families and friends who are living or have lived with the disease of alcoholism.

Business Structure

- ► AA & Al-Anon General Service Office (GSO) supports USA and Canada
 - AA GSO and Archives New York City, NY USA
 - Rent control?
 - Special deal? (Rockefeller owned building)
 - Al-Anon GSO Virginia Beach, VA USA
 - 1994 WSC approved purchase of property outside large metropolises
 - 1996 Purchased land and building & moved
 - 2011 Paid off 15 yr mortgage
 - Intergroup (group partnerships) exist to provide satellite GSO services.
 - Maintain phone lists and PO Boxes, receive mail and phone calls and forward as appropriate
 - Publish meeting lists,
 - Plan and conduct program-exchange meetings,
 - Stock and distribute conference approved literature (CAL), and publishing newsletters.
 - Intergroups exist outside of the WSC structure but must register with the World Service
 Office to distribute CAL.
 - Groups that participate elect an Information Service Representative to act as a liaison between the group and the service office
- ► International AA and Al-Non GSO's are independent



Organizational - Common

- ▶ Upside down pyramid service structure
 - Groups/Area/Region/World Service
 - National Service Offices (International)
 - Zones/Zonal
 - Combine Regions into groups based on common Time Zones or Geographical groups
- ► Self Support 7th Tradition Contributions
 - Goal 70% Contributions to 30% Literature sales
- ► Term limitations & Rotation of Service
- ► Regular Survey of the Fellowship members
 - 1977 Young People AA
 - 2013 -Al-Anon



World Service Conference - AA

- ► General Service Conference (GSC) for USA and Canada is held annually
 - AA has 2 distinct parts of GSC
 - AA World Services
 - AA Grapevine
- ► International GSO's hold separate conferences
- ► World Service Conference is held every 2 years
- ► The U.S./Canada service structure has 93 areas that are part of 1 of 8 regions. Regional Forums meet quarterly in 1 of the 8 regions of the U.S. or Canada that has extended an invitation. A Regional Forum is held in alternate years in each region on a rotating basis.
- ► Meeting of the Americas (Zonal meeting) is held in alternate year of WSC
- ► AA uses hybridized parliamentary procedures.
 - A.A.'s General Service Board has 21 members:
 - Class A are 7 non-alcoholic trustees who are chosen based on their business or professional backgrounds. They can provide services that Class B trustees, who are recovering alcoholics, cannot, such as providing public information.
 - Class B has 14 alcoholic (10 years sobriety) trustees
- ► The International Convention is held every 5 years




World Service Conference -Al-Anon & Alateen

- ► World Service Conference (WSC) for USA and Canada is held annually
- ► Al-Anon uses Knowledge Based Decision Making (KBDM)
 - The Area Delegates (66), Board of Trustees (11), Executive Committee (8), and Voting WSO Staff Members (8) have voice and vote. Non-voting WSO Staff members that work at the World Service Office in service roles affecting the members of Al Anon worldwide as well as other Staff and Volunteers have voice
 - Board of Trustees consist of not less than 7 nor more than 21 persons with the following classifications: Trustees at Large (6), Regional Trustees (5), Lifetime Trustees, and a Sustaining Trustee.
 - Members of the Executive Committee (8) have voice & vote on matters affecting Al-Anon as a whole
 - Director of Finance & Operations *Non-member, Non-voting
 - Associate Director—Brand Communications** Non-voting
- ► International GSOs hold separate conferences
- ► The International Al-Anon General Services Meeting is held every 2 years
- ► The International Convention is held every 5 years

World Service Conference - NA

- ▶ NA uses Consensus Based Decision Making at all levels of the service structure.
- ► For decision making purposes, conference participants are defined as regional delegates, zonal delegates, and World Board members.
 - Regional and zonal delegates make motions and have voice & vote in business sessions.
 - World Board members can make motions or proposals but do not vote during CAR-related Discussion and Decisions sessions
 - World Board consists of up to 15 members elected by at least 60% at WSC
 - WB are all NA members with ≥10 years of clean time
 - WB pool candidate required to have experience level that benefits a specific interest within service structure
 - Executive Director of the World Service Office does not have a vote nor make motions or proposals at the conference
 - Humann Resource panel comprised of 6 members that have completed their WS commitment
- ► World Service Conference is held face-to-face every 3 years
 - 2023 WSC changed WSC from every 2 years to every 3 years for 2 cycles, then reevaluate
 - Interim virtual WSC to be held mid cycle to vet and prioritize ideas
 - Straw polls are used to reach consensus prior to WSC
- Delegate costs paid by WSC
 - 2023 WSC passed to allow Regions the option to pay for equalized expenses.
- NA is moving to Regional delegates attending the Zonal Forums. Zonal delegates attend WSC
 - Zonal Forums held face-to-face every year
 - Zonal Virtual meetings held monthly to quarterly
 - World Convention is held every 3 years



World Service Conference - OA

- ► World Service Business Conference is held face-to-face every year
 - Delegates from intergroups, service boards, regions, and the trustees
 - OA has up to 17 Trustees
 - Delegate cost is paid by Service Body, Self, or Delegate Support Funds through the World Service Office
- ► The board & WSC follow a consensus and group conscience process except for elections and budgets.
- ► World Service Convention 2016, 2025



Finances

- ► Typical Budgetary Process
 - Fellowship develops 5- and 10-year Growth objectives at WSC
 - Committees propose budgets based on objectives & estimated income
 - Committees reconcile budget with projected income until balanced (not negative)
 - Final proposed (audited) budget published in CAR and voted on at WSC
 - Budget, cash flow, and income are reconciled at least monthly
- ► Self Support 7th Tradition Contributions
 - Goal 70% Contributions to 30% Literature sales



Finances - AA

- ► AA has \$13M Prudent Reserve in investment earnings
- Publishing gross profit has declined for 4 consecutive years
- ► The core of Self Support is that many members of the Fellowship make smaller contributions and not based on the few who make large contributions.
 - Groups contribute 59%; individual members contribute 31%; and 10% from Intergroups, Central Offices, Areas, and Districts.
 - About one third of groups contributed an annual average \$317.01.
 - Average individual contribution was \$121.79
 - 64% of group contributions and 69% of individual contributions were ≤\$100 or less.
 - Only 54 individual contributions were the maximum allowable \$5,000
 - 18,284 individual contributions were ≤\$100

- ► GSO's services funding comes primarily (approximately 80%) from group contributions, the Birthday Plan and Anniversary Campaigns, central office/district/area contributions, and excess funds of AA events or conferences. The balance is made up of profits from the sale of AA literature.
- AA has historically accepted Legacy donations.

Finances - Al-Anon

- ► Al-Anon has a \$6.3M in their Prudent Reserve in investment earnings
- ► Ran ≈\$200K deficit 2022 & 2023.
 - Contributions & Literature sales did not meet planned budget
 - Al-Anon has been sending out quarterly donation appeals
 - Literature sales have been down for over 4 years
 - Continue to reduce expenses without reducing services.
- ▶ Only 52% of the 13,841 groups contributed.
 - If all the registered groups contributed \$283.33 cost per group that would equal \$3.9M in contributions.
 - If the 52% of groups that contributed; all contributed the \$283.33 cost per group, this would meet the 71% goal.
- ► Al-Anon has historically accepted Legacy donations.

Finances - NA

- ► NA has a \$8.5M in Assets with \$1.5M Prudent Reserve in investment earnings
- ► NAWS income dropped 85% in 2020
 - NA executed an Emergency Reduced Budget for 2020 & 2021
 - 2020 \$3.9M to fund 75% of services
 - 2021 \$1.8M to fund 70% of limited services given emergency budget & layoffs
 - NAWS laid off new hires, furloughed half remaining staff, & all staff were half-time
 - NA requested and received emergency member contributions
 - 2021: 95% income came from Fellowship contributions
- ► Member contributions are steady at 24% and new literature sales and miscellaneous income is 78% of NAWS operating income

Finances - OA

- ► OA has a \$2.76M in Assets with \$1.4M Prudent Reserve in investment earnings
- ► Executive Committee of BoT reviews the budget every October. Line-by-line accounting of what has occurred in the past and expectations for the future.
- ▶ OA submits finances to yearly audit
- Audit results sent out ahead of the annual
 WSC & on website
- ► FY 2023, \$1,876,850 budget was approved
- OA has two main revenue streams contributions and literature sales.
 - FY 2022
 - Contributions \$970,001 (62%)
 - Literature \$461,456 (29%)
 - Digital and audiobooks \$142,842 (9%)

Literature

- ► AA, Al-Anon, NA, & OA use same basic process for Conference Approved Literature (CAL)
- ► AA, Al-Anon, NA, & OA have replaced text with gender neutral language.
 - 2022 petition to replace gender neutral "people" back with "men and women" in AA Preamble
- ► AA, Al-Anon, NA, & OA have tried unsuccessfully to replace "God" with "Higher Power" in Steps and Traditions.



AA Literature

- ► AA has 2 publishing houses--AA World Services and The Grapevine.
 - AA Grapevine produces a monthly journal by a staff of professional editors, writers and artists who are members of AA.
 - Literature is available both through the AA World Services and AA Grapevine websites.
- ► Literature is published in 3 languages: English, French, & Spanish.
 - Translations of the Big Book, "Twelve and Twelve" and other A.A. literature in 47 languages.
 - The A.A. message is accessible to all alcoholics: products in ASL, U.E.B. (braille), large print, audio and more.
 - Literature available includes books, pamphlets, audio, videos, and eBooks
- ► The AA Big Book was originally written at a high school reading level in 1939
 - AA is looking at making the Big Book more accessible while preserving its message by rewriting it for a middle school reading level with current language



Al-Anon Literature

- ► Al-Anon/ Alateen CAL has books, pamphlets, workbooks, free downloadable products, magazines, & group supplies
 - CAL is published in three languages: English, French, and Spanish.
 - Magazines:
 - Al-Anon Facing Alcoholism (online)
 - The Forum (Subscription)
 - Permission to publish CAL is extended only to national Al-Anon General Service bodies in countries outside the United States and Canada.
 - Occasionally permission is extended to Al-Anon Central Service Committees,
 Centers, or even a single group, with the provision that the right to publish be relinquished when a general service body is formed.
 - All translations of Al-Anon CAL to other languages are to be submitted to the WSO for review and approval before permission to print or reprint is granted.
 - Al-Anon literature in translation should conform to the spirit and meaning of the original English version.

NA Literature

- ► NA Conference Approved Literature (CAL)
- ► All NA Fellowship-approved recovery literature is protected under the Fellowship Intellectual Property Trust.
 - Recovery Literature— Written by members, NA literature offers identification and a message of hope to the still-suffering addict.
 - NA eLit is available in various formats and languages. ePub books is a combination of all electronic literature sales.
 - Audio of Basic Text: NA is making audio versions of the text available at no cost on an experimental basis.
 - They plan to post audio versions of the text in each language as those versions are finalized toward their vision that "every addict in the world has the chance to experience our message in his or her own language and culture."
 - Other recovery literature includes all Fellowship-approved Informational Pamphlets (IPs) and booklets.
 - 72 languages are spoken at NA meetings and literature is translated and published in 36 languages.
 - Development costs, professional translations and printing are included in the cost per item during literature production.
 - NA Basic Text in other languages will be allowed to replace 5 stories written by/in the native language (passed 2023 WSC)



NA Literature

- ► Recovery Literature Project Plans: NA learned during the last cycle how to complete a book-length piece through publication without meeting face-to-face by leveraging internet technology.
 - One reason they were successful is that the "Spiritual Principle a Day" workgroup had met in person several times during the cycle before.
 - They wouldn't recommend a completely online approach for a workgroup tasked with producing a long piece of literature
 - Virtual work can be ideal for shorter pieces such as IPs.
 - They intend to do all the work virtually for the two literature projects in the 2023 CAT—accomplishing work through surveys, input forms, webinars, and/or virtual workgroups or focus groups.
- ► "Invest in Our Vision": Project is focused on communicating the connection between pursuit of "A Vision for NA Service" and the concept of self-support.
 - The goal is to raise understanding of and commitment to the need to contribute both time and resources to NA, and NA World Services in particular.



OA Literature

- ▶ The literature committee is active. There are funds for translation.
- ▶ In 2022, OA continued to offer more online literature
- ► Literature costs increased to meet the vigorous rising costs of paper and shipping and to standardize the pricing structure of pamphlets, books, and workbooks.
- ▶ OA Literature:
 - Newcomer Information

AA Outreach

- ► Group, Intergroup, District and Area Committees are organized to coordinate service work throughout the Fellowship. Communication and experience are shared through regular meetings of these groups.
- ► AA conducts regular survey of the membership to identify needs
 - 1977 survey over the previous three years the proportion of young members (those under 30) in the U.S. and Canada had jumped 50 percent and now accounted for almost 20 percent of North American membership.
 - Surveys done by AA in Argentina, Colombia, El Salvador, Finland, France, Mexico, New Zealand, the United Kingdom, and West Germany yield similar results.
 - Young People in AA meetings and new literature were developed leading to a growth in the Fellowship



AA Outreach

- ► AA uses service committees to focus their outreach efforts on specific areas. Accessibility, Archives, Corrections, Cooperation with the Professional Community (CPC), Literature, Public Information, Treatment, and Remote Communities Committees
 - Make sure there is an A.A. presence in underserved areas consider starting meetings in communities where none exists.
 - Work directly with existing members in underserved communities to take regular A.A.
 meetings onto Native American reservations, into inner-city communities, special
 language enclaves, remote areas, or help set up online meetings and mobile
 collaborations.
 - Provide regular reports in accessible formats of service workshops, district meetings and other service information that will help keep these communities connected to the whole of A.A.



Al-Anon Outreach

- ► Member Surveys of the membership to identify needs
 - Al-Anon's 2018 Membership Survey states "35% of the members came specifically because of someone's use of drugs."
 - The survey also showed that 78% of these members eventually came to realize that someone else's drinking also affected their lives.
- ► Large toolbox of Outreach tools
 - Road signs
 - Interview Requests
 - Posters: Billboards, transit systems, movie theaters, and bulletin boards are popular ways to display Al-Anon posters.

NA Outreach

- ► The spiritual principles of the NA steps, traditions, and concepts guide in pursuing their public relations aims and efforts to enhance NA's public image and reputation. These principles apply to their community and service efforts as well as to the personal behavior and attitude of individual NA members.
- ► NA's message is "that an addict, any addict, can stop using drugs, lose the desire to use and find a new way to live."
 - Relations with the public enable NA to share this message broadly so that those who
 might benefit from their program of recovery can find NA.
 - NA performs public relations service to increase the awareness and credibility of the NA program.
 - They share their message openly with the public at large, with prospective members, and with professionals.
 - Maintaining an open, attractive attitude in these efforts helps create and improve relationships with those outside the fellowship.
 - Establishing and maintaining a commitment to these relationships can help NA to further their primary purpose.



NA Outreach

- ▶ Goals that NA can strive to fulfill in making NA a visible and attractive choice for addicts
 - Clarify what services NA can and cannot provide to the community.
 - Make NA members more aware of their role in NA's public image.
 - Aim for the public to recognize NA as a positive and reliable organization.
 - Develop valuable relationships with professionals and the public
- ► NA members bring meetings into hospitals and institutions (H&I)
 - Area's support H&I activities
- ► NA supports NA communities in need and incarcerated members by providing free or subsidized NA literature.
 - NAWS spends >\$500K/year to supply literature for free or at reduced prices.
 - Sending literature to those in need continues to be a priority despite the financial challenges of FY 2022.
 - Starting in 2020, free downloadable PDFs of Recovery literature became available on NA website



NA Outreach

- ► The Fifth Tradition states, NA's Primary Purpose is to carry the message to the addict who still suffers. This principle reflects that, regardless of age, race, sex, sexual identity, creed, religion or lack of religion, there is a home in NA.
 - Consider the community in which you live and then look around at your meetings and see, really see, who is there and who is not there. How can we help that still suffering addict find the commonalties we all share?
 - It may be difficult to see the faces of those who are missing from your local Fellowship, by definition; they are not there!
 - Think about the entire range of members of your community, for example, seniors, youth, addicts with differing types of disabilities, such as hearing or sight impaired, mothers, people of color, women, professionals, economic status.
 - If our meetings do not reflect the community around us, it is not that there are no addicts from those backgrounds. It is more likely that we have not yet successfully reached these suffering addicts.
- ▶ Diversity is a foundation block of NA. NA repeatedly states "Diversity is our Strength". It is the responsibility of NA members, as well as members of Public Information, to notice our local membership and to formulate a plan to reach out to those who are missing.
- ► Encouraging diversity is enhancing Outreach.



OA Outreach

- ► The Outreach committee is active. There is also a "12th step within" committee for inreach.
- "Unity with Diversity" Policy 1992a (amended 2013, 2021, 2023)
 - THE FELLOWSHIP of Overeaters Anonymous encourages and promotes acceptance and inclusivity. All are welcome to join OA and are not excluded because of race, creed, nationality, religion, gender identity, sexual orientation, or any other attribute. We welcome all who share our compulsion. ...
- ▶ July 11,2023 letter from OA Board of Trustees and Unity with Diversity Conference Committee: What Is an Outside Issue: Are We Being Open-Minded in Our Meetings?
 - We all come from different backgrounds and experiences. The OA program is for everyone with a desire to stop eating compulsively. We are meant to be inclusive and welcoming to all.
 - A subcommittee of the Unity with Diversity Conference Committee has been in contact with some members of specific-focus groups, including BIPOC, LGBTQIA+, and Health Issues, and has found that, despite all previous statements on inclusivity, there are still members who don't feel safe or included.
 - The subcommittee was distressed to hear that some OA members, when sharing their life realities, were told that their life experiences were considered outside issues and were shut down.
 - How will we ensure that everyone is included?
 - The Unity with Diversity Committee's primary concern is that all OA members, in all meetings, feel safe while sharing their experience, strength, and hope and are not told that their share is an outside issue. Everyone needs to be able to share at meetings about factors in their lives that could cause them to act out with food.
 - The Unity with Diversity Committee is discouraged that efforts to date have not brought about sufficient change.
 - It is an urgent matter that people are not silenced at OA meetings. Action is required from the Board of Trustees and the whole Fellowship to create a safe space for all to share.



- ► Russian NFG has reorganized
- ► In 2017 they became AWARE that the NFG in Russia was in Crisis
 - The legal entity did no carry out activities in the legal field of the country
 - The financial activities of the fellowship were fully carried out by the Board of Trustees (BoT): it created, oversaw, and managed the budget, but did not provide reports to the fellowship
 - The BoT fully controlled the activities of the Russia Service Committees
- ▶ End of 2017, they ACCEPTED that the NFG in Russia was in Crisis
 - The services of most of the Russia Service Committees was paralyzed
 - BoT determined the rules of the National Service Conference
 - No two-way communication between service structures and groups
 - Groups were unfamiliar with Concept 2 & did not take on any responsibility for the Nar-Anon services
- ▶ Beginning of 2018 they ACTED and started working to repair the NFG in Russia
 - Groups and regions stopped making their contributions as their Seventh Tradition
 - Fellowship expressed the lack of trust to BoT, and BoT resigned in early 2018
 - Groups and the RSC, based on Concept 2, created a Temporary Service Structure to overcome crisis, conduct full inventory of fellowship service structure, and prepared & held National Service Conference 2018
 - Small study groups & workshops were organized to work the Traditions and Concepts of Service in Nar-Anon. Eventually, it became clear that theoretical knowledge was not a guarantee of a healthy fellowship. It was necessary to apply these principles in all our affairs.



▶ What has been done

- The current service structure of the Russia Nar-Anon has been created based on the constant inventory of groups and service structures.
- National Service Conferences of 2018, 2019, 2020, 2021, 2022, necessary decisions were made to overcome the crisis and continue to develop the fellowship
- Russia Nar-Anon has become part of the world fellowship: each Russia Service Committee is now associated with the World Committee in its profile; Russian RSCs exchange experience with the regions of the Nar-Anon around the world; at the WSC 2023 the Russia fellowship was represented by six regions out of seventeen.
- Russia Nar-Anon closely cooperates with world service structures as outreach service. Due to national peculiarities, legal aspects, natural factors and mentality the conference approved outreach materials are not suitable to perform outreach in Russia.



- ▶ What is Now
 - Annual National Service Conference in virtual format and without equalized expenses
 - Approves bylaws
 - Approves & modifies GLS of NFG in Russia
 - Approves annual budget and financial report
 - Holds elections of BoT (Term limit 4 yrs)
 - Created 12 Russia Service Committee
 - BoT between Conference
 - Oversees activities of legal entity on a daily basis
 - Presents quarterly reports on finances and financial activities of legal entity to fellowship
 - Provides the organization of Nar-Anon services in Russia through all Russia Service Committees
 - Provides support & assistance to all Russia Service Committees, but does not govern them
 - Can solve any urgent issues by contacting the Forum of delegates and alternate delegates, if needed between National Service Conference
 - Service position of delegate and alternate delegate at the National Service Conference is fulfilled by the RSC Chair and Vice Chair respectively
 - Forum of Delegates & Alternate Delegates created -WhatsApp chat
 - Discusses common welfare topics (CWT)
 - Reviews urgent requests of BoT
 - o helps writing motions for National Service Conference &WSC
 - Russia Service Fellowship Development Committee serves as link between groups & service structures to assist fellowship development & ensure two-way communication between groups & service structures



- National Service Conference created Russia Service Traditions and Concepts Committee to be Guardian of Traditions, Concepts of Service, & Guidelines
- All regions, in accordance with decisions of National Service Conference, have their representatives in all Russia Service Committees to ensure two-way communication & full group conscience of the fellowship
 - All RSC are encouraged to participate in creation & amendment of the Bylaws
 - All RSC send their trusted servants to service in Russia Service Fellowship Development Committee
 - Treasurers of all RSC are encouraged to serve in the Russia Service Budget and Finance Committee
- Russia Service Traditions and Concepts Committee nominates candidates to BoT for elections at National Service Conference based interviews & credential documentation
- Russia Service Committees use e-mail for official correspondence
- Reports & presentations of the BoT and Russia Service Committees ensure the awareness and trust of the fellowship. The BoT submits to National Service Conference a consolidated report on activities of BoT & all Russia Service Committees. This consolidated report is part of CAR

► Today

- Service structure of the Russia Nar-Anon is developing & there is a bond of trust in the fellowship
- Nar-Anon family groups in Russia took responsibility for everything that happens in the fellowship.
- Activities of National Service Conference, Russia Service Committees, BoT, RSC, and legal entity are all overseen by groups.
- Annual National Service Conference in virtual format and without equalized expenses ensures
 equality and possibility of participation of delegates & observers from all regions

2024 Budget of \$420,000

- ► Note other fellowships have \$ 5.7 million budget
- ► Slight increase from 2023 due to inflation (5.18%)
- ► Operating Service Level of \$35,000 Monthly
- ► Operating Service Level of \$ 1,150 per Day



Principles:

- Concept 2 "The final responsibility and authority for Nar-Anon services rests with the Nar-Anon Family Groups". Direct member contribution to the World Service is most effective.
- Concept 11 "Nar-Anon funds are used to further our primary purpose to carry the message and must be managed responsibly."
- ► The World Service Office is run frugally and responsibly.
- ▶ The office is small but effective for personnel, storage, and printing.
- Transition to Electronic Age Different priorities will fuel changes to the World Service Office as we currently know it
- ► The World Service office staff are Nar-Anon members and have sacrificed greatly since the pandemic including pay level and hours



Takeaway:

- ▶ We have a duty to support that which has been given to us and pass it on.
- ▶ We have a duty to be a part of this change and be a part of the solution.
- ► The monthly and daily contributions by regions, groups, members, and international groups were just shared.
- ► It doesn't take a lot to fund our fellowship, but it does take all of us contributing.
- ▶ Let's find a solution, not just revisit the problem.
- ▶ We are ALL challenged to find a solution.







- Newsletter CAN be used as a topic for meetings
- The newsletter cannot be used as a tool to bypass the CAL approval process, which has been rumored at times.

This is the first of a series of Newsletters published by the los Angeles Intergroup with the help of material of interest from all members of the groups.

In retrospect, the past year and one half has gone very quickly for me in Intergroup. I feel our fellowship has increased greatly because of group cooperation; and contributions to our headquarters. These have been sizeable for so few groups. I am sure with your continued cooperation we will grow immensely.

DEADLINE FOR NAR- A NEWS 5th of month

How many of our membership realize that the only way Intergroup continues to grow is because it is supported only by contributions of the groups.

SPEAKERS LIST

Intergroup is compiling a speakers list. Those of you who would like to be included on this list please send your name and address, telephone number to Janet. If anyone is sending someone elses name be sure that there is permission to submit the name and that the information is correct.

To all of you out there this NAR-A NEWS is for you. I can only put in it what you give to me, so send in what is happening in your group. Suggestions ar e welcomed by your service board of Intergroup so that they can serve you. Please have patience with me until me find an editor. This is my first attempt.

INTERGROUP STRUCTURE

Any Nar-Anon Group can become a member of Intergroup by informing the Intergroup Secretary of its desire to participate and by electing a delagate and an alternate to represent their group. The intergroup works for all groups. Each group is equally represented at Intergroup meetings.

PURPOSE: The sole purpose of inter-Group is unity of all Nar-Anon Groups in this area, so that each group supports the others in our effort to carry the message. Inter-Group was formed to work with members know as Service Board members in handling Nar-Anon business outside the groups and to assist the groups in handling problems that cannot be worked out in the groups.

COMPOSITION: Shall consist of all Nar-Anon Groups who are interested in Inter-Group activities. The officers of Inter-Group shall consist of Chairman. Secretary, treasurer, Service Committees and Delegates.

PURPOSE: As individuals compare their experience in group meetings, so delegates share their group problems and experience in Delegate's meetings.

DUTIES: To bring to the attention of Inter-Group the wishes, desires and requests of their home groups. To act as spokesman between the individual groups and the Service Committee.

SERVICE COMMITTEE: Is the guardian of the area service in conformity with the twelve Traditions of Nar-Anon. To handle questions of policy, public

relations and Inter-Group relations and any internal problems that arise.

To all of you in Nar-Anon that aren't quite sure about Inter-Group and the Delegates perhaps this little bit of information will help clarify just what we are. There many of us coming into Nar-Anon hearing the word, "Inter-Group" mentioned after a few meetings and wonder what it is. I feel very fortunate that I can be a part of Inter-Group and help serve. This is my way of giving back all that has been given to me in Har-Anon.

Keep in mind the date of Inter-Group meetings, the third Wednesday of each month and meetings are held at 5750 W. Clympic Blvd., Los Angeles, California 8:00 p. m.

NEW GROUP

The World Service Office depends largely on the sale of literature for support; when this is siphoned off to other segments of the fellowship who publish unapproved literature it deprives the WSO of funds to which it is entitled.

A World Service Literature Committee will be appointed when we attend our first World Conference (soon we hope) Anyone writing new literature should have the approval of such and this should be sent to Nar-Anon Headquarters, Inc. for publishing. Headquarters Incorporated is the Legal Arm of our fellowship. The groups are TRADIONAL.

How can we help form an "informed group conscience" at every level, Group, District, Assembly and World Service? Group conscience cannot be formed until such time we have a World Service Conference. At the present time all new literature begins with the approval and recommendation of the World Service Office.

All groups should have a group representative(GR)a District(R) and should hold committee meetings which lead to District area meetings. The GR attends District meetings where problems are discussed and information is exchanged and where the GRs elect a District Representative(DR) to represent the District. (A District is a number of groups close enough for convenient attendance at meetings.) A Delegate is elected from among the DRs the Delegate represents her or his state, at the World Service Conference.

Please keep in mind who you choose for the GR as they will vote for District R. This should be taken seriously with all groups. Are you aiding your committeeman to become conversant with the problems and opinions of the District?

Material will be provided to all groups which will outline the necessary steps to elect a DELEGATE for your state to serve at the first WORLD SERVICE CONFERENCE. With the cooperation from all groups we shall try for 1984. The WSC makes the group conscience available and effective for all NAR-Anon. It is the pratical means by which the group conscience can speak.



INQUIRIES

Response in a unified voice

The World Service Policy and Guidelines Committee ensures a unified voice in its official responses. When an inquiry is received, the committee chair or secretary acknowledges it and sets a response deadline. The committee serves as a resource for the fellowship, clarifying policies and guidelines found in our service documents or addressing situations that can be clarified through our 12 Traditions and 12 Concepts.

Committee members have discussions in our monthly meetings on the inquiries to come to a group conscience - the the secretary prepares a draft letter, which will be sent to all members to oversee the draft form and give their inputs. The Chair and/or secretary consolidates their feedback into a single response representing the entire committee.

For any inquiries, feel free to contact the committee via email at **pandgcommittee@nar-anon.org.** It's important to note that inquiries should be related to the committee's purpose. We do not intervene in legal situations; for those cases, other service bodies can provide specific comments.





ARTICLES FOR THE SERENITY CONNECTION

An ongoing dialogue with the fellowship

These articles are grounded in the committee's responses to a variety of inquiries from regions and members. They reflect the committee's ongoing dialogue with the fellowship and underscore the collaborative efforts to address questions and concerns. This exchange not only serves to resolve queries but also provides insights that may resonate with and inform other structures worldwide.





ROUNDTABLES

Committee designs and sends a survey with questions to Nar-Anon members across all regions. This survey is based on the topic that will be discussed during the roundtable. Based on the survey results, responsibilities are allocated among all committee members for providing responses. Additionally, the roundtable is organized on the scheduled date. In our last roundtable, we discussed the service structure, and we had an attendance of 50 members.

We are actively encouraging the use of these surveys and greater participation in the roundtable. Initially, our plan was to hold three roundtables per year when there was no World Service Conference. However, due to the current interim conference, we are reevaluating this schedule.







MOTION REVIEW

Promoting informed decision-making

We have an established procedure in consensus for reviewing draft motions submitted via email by various service bodies for review/feedback to our Policies and Guidelines before WSC. Through this process, we carefully evaluate each motion, considering alignment with Nar-Anon's principles, past unsuccessful attempts in recent conferences, and the motion moratorium.

Our goal is to ensure a transparent review, contributing to informed decision-making. We provide feedback and input to the authors of each motion within a 3-month period stipulated in the conference timeline. In this conference cycle, we have received 23 motions from 10 different service bodies.



REVIEW OF NEW SERVICE AND OUTREACH LITERATURE/MATERIALS





The World Service Policy and Guidelines Committee plays a key role in review of new service and outreach literature/material (according to GWS pg 25)



Our review focuses on adherence to the 12 traditions, 12 concepts, policies, and guidelines.

Carefully reviews these materials, which include manuals, pamphlets, or service handbooks related to policies and/or guidelines.

Report our findings back to the WSB for their final approval..

Introduction:

At the World Service Conference (WSC) 2023, attendees voted to refer *Motion 20* to the newly formed Ad hoc Transition Committee appointed by the World Service Board.

Motion 20:

No mandatory contributions are charged to attend the World Service Conference. Remove any information about payments or equalized expenses for the World Service Conference from the Guide to World Services and the Guide to Local Services.

Assignment of Transition Ad hoc Committee

To research the possibility of a no cost or lower cost conference.

Summary

If the World Service Conference (WSC) of Nar-Anon Family Groups continues to be held subject to parliamentary procedures, the services of a qualified parliamentarian will be required.

The WSC will have a cost. Changing to Consensus Based Decision Making (CBDM) may eliminate the cost of a parliamentarian but add a cost for time, training, and the development of experience among the broader fellowship.

There is no guarantee that the use of a parliamentarian would still not be needed. Our facilitators are not professionals.


Summary

The Interim World Service Conference (IWSC) 2024 will answer many questions about the possibilities and effectiveness of a strictly virtual conference in 2025.

The IWSC 2024 will eliminate certain costs of a parliamentarian, travel, food and wages for secretaries.

Unknown costs of technical production may need to be recognized and accounted for to assure the production team has all the funded support necessary to effectively function from their virtual locations.


Summary



Ultimately, the way to reduce the cost of a WSC is to reduce the duration of the conference.

Motion 26 was passed in WSC 2023 for the Policy and Guidelines Committee to review submitted draft motions. This may help reduce duplicate motions, offer suggestions and interact with the regions looking for clarity before the CAR gets sent out. Regions must contact P&G Committee before set deadline.

WSC 2025 Budget Proposals

- In addition to the comments and research of the committee members, the Ad hoc Committee consulted with members from the IT team, a conference secretary, and the facilitator.
- Financial information was provided by NFG World Service committee and Budget & Finance Committee.

OPTION 1: WSC 2025 - Same in-person and remote plan as the WSC 2023

The WSC 2023 was extended from six to seven hours and from five working days to a total of six days. Eight people were in person on-site at the WSO. Six people required food, lodging and travel expenses.

• Limited choices for lower cost accommodations close by

WS Board Report – Tasks 1 and 2

The April 2023 – April 2025 Conference Cycle started with five directives and/or requests from the WSC 23. I am happy to report that the WSB has executed and completed all five tasks.

- 1. Four ad-hoc committees: The four ad hoc committees were formed, Transition, Best Practices, Electronic Literature, and Social Media. The four adhoc committees have submitted their interim reports to the IWSC 24, their final reports will be sent to the requesting body at the next WSC.
- 2. The request to look at the terms of board members from two 6-year terms to one 6-year term. The WSB discussed and reviewed the terms of the current board members. Consideration of the input from the newer members of the board, the turnover every two years and number of members applying to the WSB lead to the change in the second term of the member. The board member will have the option for their second term to serve the full six years, four years, or two years.

WS Board Report - Tasks 3, 4, and 5

- 3. To increase the number of CAL electronic literature available, including translated literature. The Electronic Literature Ad-hoc committee is now a "Formatting" subcommittee of the World Service Literature Committee. The subcommittee has formatted existing CAL literature and added new items to the e-books available, like the Newcomer Booklet, which includes the Blue Book, and all the pamphlets from the Newcomer Package.
- 4. To add translated CAL to the Nar-Anon webstore. Translated literature is available in the webstore in six different languages as we receive more translated CAL they will be added.
- 5. To develop a downloadable document for virtual meetings to include only certain items. A downloadable PowerPoint for virtual meetings is available by request on the website. Go to members, virtual literature.

WS Board Report – Office relocation

The WSB stated we would investigate moving the World Service Office to a property which will reduce our rental cost. WSO and a member of the Budget & Finance Committee started the hunt again after the conference. The research sent to the board by the Budget and Finance Committee and WSO included the the lack of more lower and comparable rental prices in the area, the loss of all employees if the new location was 25 miles or more from the current location, the \$9000.00 cost of moving, and the current owner's new contract offer without an increase in the rent were all considered in the decision to stay at our current location and to sign a one year contract. The search is still on going.

WS Board Report - Communication

During the first half of this conference cycle the WSB continued serving the worldwide fellowship, having our six regular meetings per year, held roundtables with WS Conference.

Committee, Website Committee and Narateen Committee and held a roundtable with the chair and vice-chair of all the world service committees. We voted to post on the website a monthly financial snapshot, plus processed new outreach and service literature.

WS Board Report - Funding

The reality is the World Service Board and World Service Office can only work with what the fellowship gives in donations, purchase of literature and royalties. WSO staff do everything in their power to cut costs. The staff which are underpaid took off one day a week for 8 months, so the fellowship could save on salaries.

WSO - Staff

I want to share some facts about our staff – the number of years combined = 105 years with Nar-Anon. Maureen – started in 1991 by volunteering and then as a paid part-time shipper, Phyllis – from 1996 paid part-time and me - first as a volunteer (not paid) in 1992 then 2003 as executive director – we worked with the previous executive director, Louise and board of trustees. Ahou started 2014 and brought her computer and IT knowledge/website which we needed.

WSO - Technology

Until June of 2003 – we had no computers or even a copier – for copying we used the fax machine feature for copying – sadly those copies are fading or have disappeared. As you saw in the video – all printed matter (letters, directories, etc.) the IBM Selectric electric typewriter was used.

We received donated pcs' which we appreciated – but had many problems with each not able to communicate with other computers – we had wonderful members with computer knowledge come when needed to help when we experienced problems – even when our computers were wiped-out – picked up a virus from web browsing.

WSO - Index Cards

2004 we were able to lease a Canon copier – black and white – very limited on functions, but greatly needed.

You also saw our version of meeting directories – those index cards were utilized until 2008 and it was only one set and we did have occasions when an index card goes missing. We finally found a program which we had communicate between computers and each computer had access for meeting information.

WSO – Printing the SESH

Today – we are grateful our literature sales are increasing and with that comes our printing of literature needs. After looking at many options on providing Nar-Anon literature – 2008 the first softbound SESH was printed outside California as local companies did not have the capability or it was too costly. The downside was we had to rent storage to house the 7,500 books until they were sold. This involved using my pickup driving 2 miles to storage and load the needed boxes which weighed over 50 pounds. Then returning to the office (the old location) and hopefully the elevator was working, but if not – it was a job climbing the stairs with those boxes.



WSO – Literature production

There were many discussions that if there would be a copier that we could do in house printing and Konica Minolta provided a solution - 2010. I am grateful that Phyllis accepted the challenge to learn how to and started printing, binding and cutting the SESH book - as well as train staff members to be able to also do the printing, etc. The copier prints the literature you saw in the shipping department in the video. The only literature outsourced due to print restrictions - The Green Guide, Personal Stories, 31 Days in Nar-Anon, the small Blue Booklet, Slogan bookmark, Do's & Don't, Just For Today, are laminated, and table cards.

Not available yet but should be in the coming week the new Just For Day in Nar-Anon laminated bookmark. We are also happy to say our inventory includes multi-lingual literature and continues to expand as more are translated.

WSO - Staff and volunteers

The staff are multi-taskers – and we have had volunteers in past years, but we have seen economic hardships preventing many from volunteering. We do ask those Nar-Anon groups near us to announce in the meeting WSO need for volunteers. So - this a continuing challenge.

Our staff and I on a daily basis continue to remain vigil with our expenses and as you have heard during the conference – Phyllis is on top of all our needs and looks for cost effective ways to expedite.

WSO - Executive Director

As executive director – I report to the WSB, attend WSB meetings and submit reports. When necessary – contracts for the office equipment, lease of building and insurance coverage – are submitted to WSB for review. Our accounting department consists of Phyllis and myself – doing data entry which then is sent to the WSB Treasurer as she reconciles the financials each month and prepares the snapshot financials for website posting.

WSO - Video tour

We print, ship, answer phone calls and emails are just some of what is done in WSO. I hope the tour of WSO is helpful and that for those who have not had the opportunity to visit – they may better understand the day-to-day operations and the challenges we face.
